INFORMATION FOR KINDERGARTEN PARENTS



After School Enrichment is a program that gives children from kindergarten through the sixth grade a safe, fun, interesting time from school dismissal until 6:00 p.m. Next fall, our school system will operate after school programs at many elementary schools. Before school care opens at 6:45 a.m. Before school programs are offered at elementary schools with late morning bell schedules. A minimum enrollment of twenty-four families is needed for the program to operate.

If you are interested in having your child belong to an ASEP program in the fall, you may want to visit a site before the end of this school year. To arrange a visit, call the school telephone number at a school with an ASEP site, and ask for the ASEP Site Coordinator.

ASEP has an annual registration charge of \$47.00 per family. The proposed Weekly fees for the 2024-2025 school year are listed below.

Most After School Enrichment Programs are licensed and monitored by the North Carolina Division of Child Development, allowing families who are eligible for day care assistance through Child Care Resources, Inc. (CCRI) to receive assistance for children in the Charlotte-Mecklenburg Schools ASEP program. Most of our elementary school programs have earned a five-star rated license.

ASEP is open for full days during teacher workdays, early release days which fall within regular weeks of school, and during most days of winter and spring breaks. The ASEP is not open on school system holidays.

Registration for the fall term begins in late spring and is on a space-available, first come, first served basis. A tentative start date will be Monday, June 3, 2024. Registration contracts should be completed in Eleyo via ASEP website and are reviewed and approved at each ASEP site throughout the school year on a space available basis. **Early Release & Workdays option for CMS Employees only:** \$25.00 daily rate for registered students; pending program availability. Employees must provide their CMS email address to confirm employment. Parents will receive an email when their registration contract has been completed.
