

Information for Beginner's Day

The After-School Enrichment Program provides a warm, caring environment beyond school hours where students can play with school friends and have an opportunity to work on homework before the family sits down to dinner. We offer exciting activities, including sports, art activities and computer exploration, which stimulate children to be healthier and happier.

After School Enrichment Programs operate in most CMS schools, utilizing age-appropriate materials and equipment for students. From the media center to the playground, children spend out-of-school hours in safe and stimulating environments. ASEP Site Coordinators work closely with school administrators and teachers to ensure that their programs supplement the learning taking place during the school day.

Besides academic support, the ASEP program focuses on social skills development. Program leaders are respectful and positive toward children, and mindful of the importance to children of appropriate role models. Staff are trained in a conflict resolution curriculum for adults and children. Students are encouraged to develop friendships with schoolmates that for some will last many years.

Students in the ASEP participate in:

art, music, & dance field trips science & nature math centers

homework sessions computer exploration games and sports clubs . . . and more!

Most After School Enrichment Program sites are licensed by the N.C. Division of Child Development, so families may utilize subsidies from Child Care Resources, Inc. More than half of our site programs have earned the highest Five Star Rating on their state license.

HOURS OF OPERATION

Before school care opens at 6:45 a.m. and dismisses thirty minutes prior to the morning bell at schools which start at 8:15 am or later. After school operates from school dismissal until 6:00 p.m.

ASEP offers on-line registration via Eleyo platform. Registration for the 2024-2025 school year will begin in the spring. A tentative start date is Monday, June 3, 2024. On-line registration is available at www.cmsk12.org, Registration contracts should be completed in Eleyo via ASEP website and are reviewed for approved at each ASEP site throughout the school year on a space available basis. Parents will receive an email when their registration contract has been completed. A second email will be sent upon contract approval. TRANSPORTATION

CMS does not provide transportation home from ASEP. You may enroll your child at an ASEP site different from the school site s/he attends, but school bus transportation from school to the ASEP site must be coordinated between parent/guardian and CMS Transportation via the Alternate Stop request.



DATES OF OPERATION. Before and After School care begins on the first day of school and operates on all regular school days and on teacher workdays/early release that fall within regular weeks of school. The After-School Enrichment Program *does not* operate on school system holidays or program closure dates.
